



# Group Term Life Benefit for the University of Texas System's Retired Employees

Effective September 1, 2022

The death of a family member can mean not only dealing with the loss of a loved one, but the loss of financial security as well. With our group term life plan, you can achieve peace of mind by giving your family the financial security upon which they can depend.

**Eligibility:** All benefits eligible retired employees may enroll for coverage. For questions on eligibility, please refer to the Office of Employee Benefits Retired Employee Insurance webpage or contact your institution Benefits Office.

BENEFITS AT A GLANCE
<b>Retired Employee Basic Life:</b> \$10,000
<b>Retired Employee Voluntary Life:</b> You may elect one of the following options: \$7,000, \$10,000, \$25,000, \$50,000, or \$100,000
<b>Dependent Spouse Voluntary Life:</b> You may elect \$3,000.
<b>Note:</b> You must be insured for voluntary coverage above the \$10,000 basic benefit in order to elect benefits for your spouse.  No person may be covered more than once under the policy.
<b>Life Benefit Limitation:</b> Voluntary life insurance benefits will not be available for a loss caused by suicide or attempted suicide within two years after the insured's effective date of coverage.

WHEN IS MEDICAL EVIDENCE OF INSURABILITY (EOI) REQUIRED?	
<b>Retired Employee</b>	EOI is required for any increase in coverage
<b>Spouse</b>	EOI is required for spouses who elect to enroll for coverage.
<b>Note:</b> EOI is not required for spouses who were covered while the retiree was an active employee and continued coverage under the retiree plan with no gap in coverage	

WHO PAYS THE PREMIUM?	
<b>Basic Benefits</b>	UT System pays 100% of the premium.
<b>Voluntary Benefits</b>	You pay 100% of the premium.
