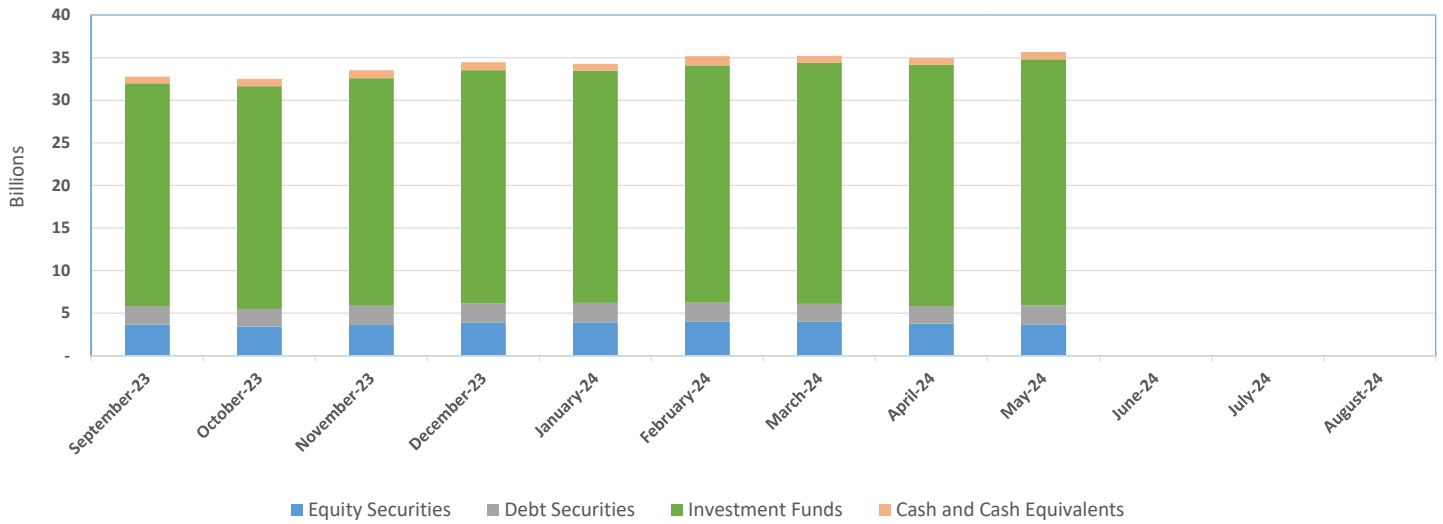


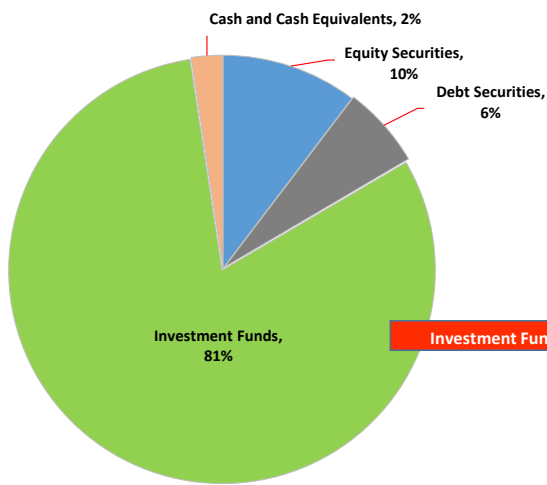

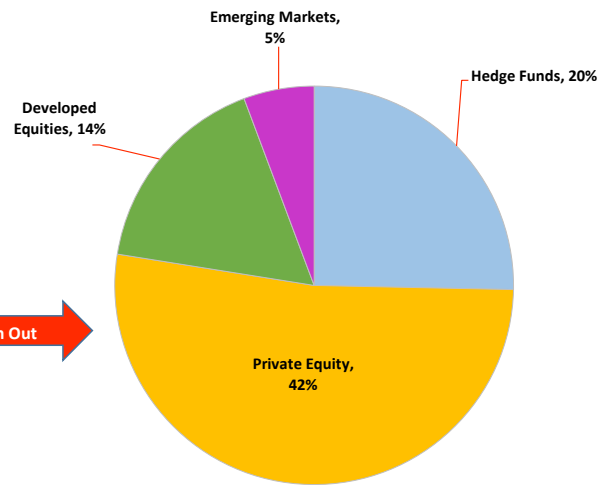
Investment Portfolio - FY 2024



Investment Portfolio as of May 2024

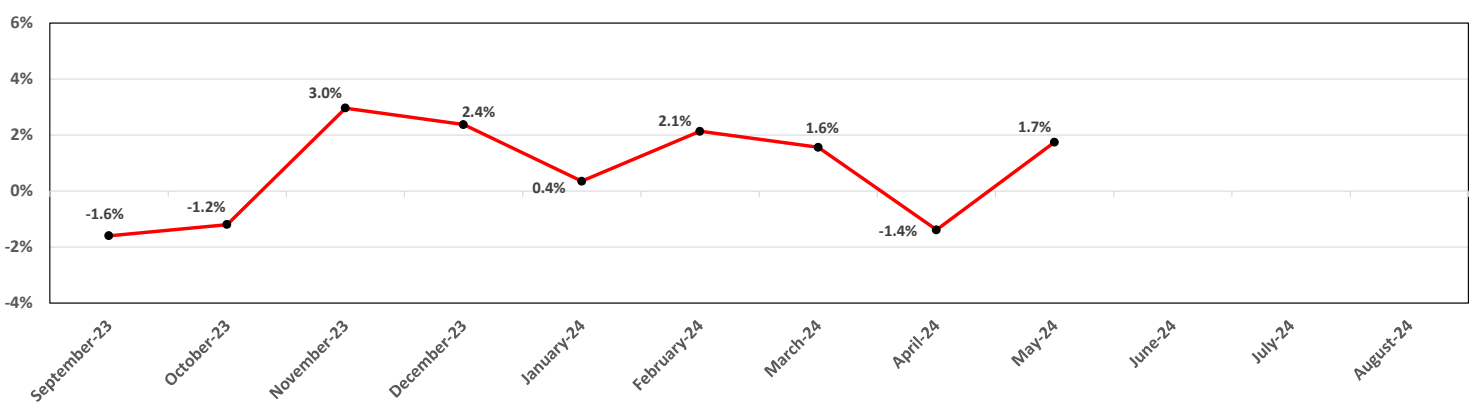


Investment Funds Breakout
