## MEETING NO. 774

SATURDAY, JANUARY 24, 1981.—At the Board of Regents' meeting on January 6, 1981, a meeting was scheduled for 10:00 a.m. on Saturday, January 24, 1981. Accordingly, the members of the Board of Regents of The University of Texas System convened at 10:10 a.m. on Saturday, January 24, 1981, in the Regents' Meeting Room on the ninth floor of Ashbel Smith Hall in Austin, Texas, with the following present:

Mr. Tom B. Rhodes, Dallas, Texas, to succeed Mr. Dan C. Williams of Dallas, Texas, whose term expired on January 10.

Each of the above took the oath of office on January 12, 1981.]

In the absence of a Chairman and Vice-Chairman, Regent Fly, a senior member of the Board, called to order the meeting of the Board and announced a quorum present.

ELECTION OF TEMPORARY PRESIDING OFFICER.--Regent Fly stated that the organizational meeting of the Board was in session and that the control first order of business was the election of a temporary presiding officer. He placed in nomination for temporary presiding officer the name of Regent Powell. Regent Newton seconded the motion which carried by unanimous vote. Whereupon, Regent Powell took the Chair.

RECESS FOR EXECUTIVE SESSION.—Regent Powell, temporary presiding officer, announced that the Board would resolve into Executive Session pursuant to V.T.C.S., Article 6252-17 to discuss Board organization.

RECONVENE. -- When the Executive Session adjourned at 10:50 a.m., the members of the Board reconvened in open session. Regent Powell reported that the Board had met in Executive Session and discussed its organization. In response to Regent Powell's inquiry as to whether there was any action from the floor, the following action was taken:

ELECTION OF JAMES L. POWELL. CHAIRMAN.--Regent Newton was recognized and moved that James L. Powell be elected Chairman by acclamation. Regent Hay seconded the motion. Temporary Presiding Officer Powell asked Regent Newton to preside. Regent Newton called for a vote. The motion prevailed by unanimous vote.

Regent Powell returned to the Chair and expressed appreciation for the confidence that the members of the Board had placed in him and said, "I shall certainly work to assist and be a leader for the Board, The University of Texas System and the State of Texas."

ELECTION OF STERLING H. FLY, Jr., M.D., VICE-CHAIRMAN. --Regent Richards was recognized and moved that Sterling H. Fly, Jr., M.D., be elected Vice-Chairman. Regent Hay seconded the motion which carried by unanimous vote.

Vice-Chairman Fly was recognized and responded: "I certainly appreciate this honor that you have given me here today. I will do my very best to fulfill the obligations of this office and to help the Chairman and the Administration to continue to build the System that was mandated in the Constitution for a university of the first class."

RE-ELECTION OF BETTY ANNE THEDFORD, SECRETARY .-- Regent Hay moved that Betty Anne Thedford be re-elected Secretary. Regent Blumberg seconded the motion which prevailed by unanimous vote. DUCHMENT
