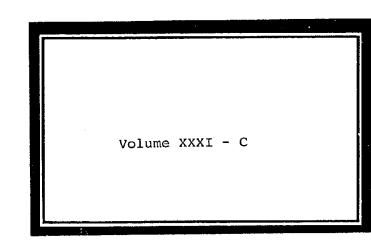

## MEETING NO. 799

WEDNESDAY, JANUARY 25, 1984.--The members of the Board of Regents of The University of Texas System convened at 7:00 p.m. on Wednesday, January 25, 1984, in the Regents' Meeting Room on the ninth floor of Ashbel Smith Hall in Austin, Texas, with the following in attendance:

Chairman Newton announced a quorum present and called the special meeting of the Board to order.

RECESS FOR EXECUTIVE SESSION.--Chairman Newton announced that the Board would recess to convene in Executive Session pursuant to <u>Vernon's Texas Civil Statutes</u>, Article 6252-17, Section 2(f), to consider an emergency item related to an amendment to the lease agreement for the operation of commercial vineyards on Permanent University Fund Lands in Pecos County, Texas.

RECONVENE.--At 7:23 p.m., the members of the Board reconvened in open session to consider the item listed on the agenda. In response to Chairman Newton's inquiry regarding the wishes of the Board, the following action was taken:

U. T. SYSTEM: APPROVAL TO AMEND LEASE AGREEMENT WITH GILL-RICHTER-CORDIER CORPORATION, A TEXAS CORPORATION, FOR OPERATION OF A COMMERCIAL VINEYARD AND AN ASSOCIATED WINERY ON PERMANENT UNIVERSITY FUND LANDS IN PECOS COUNTY, TEXAS.--Vice-Chairman Baldwin moved that the Board authorize Chairman Newton to execute an agreement with Gill-Richter-Cordier Corporation, a Texas Corporation, to amend the Lease Agreement related to commercial vineyards on Permanent University Fund Lands in Pecos County, Texas, in accordance with the parameters discussed in Executive Session. Regent Richards seconded the motion which prevailed by unanimous vote.

ADJOURNMENT.--There being no further business, the meeting was adjourned at 7:25 p.m.
