I also recommend approval of the following Central Administration budget items:

OUT-OF-STATE TRIPS: I recommend approval of the trip of Dr. L. D. Haskew, Vice-President for Developmental Services, April 17-19, 1956, to Washington, D. C., to represent the University at a briefing session called by the Department of State on University contracts in foreign countries, expenses to be paid from Clerical Assistants, Office and Travel Expense, Office of the President.

I further recommend ratification of your approval by "no-objection-within-five days" procedure of Mail Dockets 4 and 5, copies of which are attached as part of this docket.

SOUTHWESTERN MEDICAL SCHOOL: I recommend approval of the appointment of Dr. F. J. Bonte as Professor of Radiology and Chairman of that Department, effective July 1, 1956, at an annual salary of \$25,000, payable \$10,000 from the General Budget and \$15,000 from Parkland Hospital Special Activities Fund, General Budget funds

for this period to come from Unallocated Salaries. Also, approve the transfer from Unappropriated Balance of \$5,000 to this Department for Maintenance and Equipment, the 1956-57 Maintenance and Equipment account to be reduced by this amount.

CHANGE ORDER TO CONTRACT FOR PARKING LOTS AT DENTAL BRANCH AND M. D. ANDERSON HOSPITAL AND TUMOR INSTITUTE: Mr. C. H. Sparenberg, Comptroller, has signed a change order in the amount of \$285.00 to contract with Republic Construction Company, Inc., of Houston, for construction of parking lots at Dental Branch and M. D. Anderson Hospital, to provide for removing a light pole on the driveway between the present parking lot and the new parking lot at the Dental Branch, and to erect a barricade between the two parking lots, funds to come from the Allotment Account for the Parking Lots as shown in the Plant Funds Section of the Dental Branch books, with Architect's Fees at 6% to come from the same source. I recommend approval and ratification of signature.

GIFT OF EX-STUDENTS' ASSOCIATION: The Executive Council of the Ex-Students' Association has sent a check in the amount of \$8,500, which sum, according to the Minutes of the meeting of the Executive Council held Saturday, April 7, 1956, is "transferred to the control of the Board of Regents of The University of Texas for use at its discretion as unrestricted funds for the benefit of The University."

At the April 18, 1956, meeting of the Board, \$4,250 was transmitted to the Medical Branch for use toward purchase of an electron microscope. I recommend that the remaining \$4,250 be allocated toward the construction cost of an educational FM radio station at the Main University, subject to the following conditions: The amount is to be deposited in a special account to be invested and held until such time as sufficient funds and pledges, from sources other than funds appropriated by the Legislature or the Available Fund, have been accumulated to defray entire costs of constructing and operating such a station for five years. At the May, 1957 meeting, the Board of Regents will review this allocation and may make other disposition of these funds if the radio station project does not appear capable of satisfactory realization at that time.

POLICY REGARDING EMPLOYMENT OF FOREIGN STUDENTS ON GOVERNMENT SPONSORED PROJECTS: The present policy on this subject, adopted October, 1954, is as follows:

Where these contracts do not otherwise prohibit such employment, a foreign student may be employed upon certification by the Director of the International Advisory Office that he has examined the student's visa and found it to be in order and has ascertained that the student has the approval of the Immigration authorities to accept such employment.

In order to permit Government sponsored research projects to employ aliens who are admitted to this country as "Exchange Visitors," some of whom are post doctoral researchers and not enrolled as students, I recommend that the authority granted in the October 1954 policy be broadened to include this group (within the scope of P. L. 414).



RESEARCH CONTRACTS: The following contracts and amendments have been negotiated by the Office of Government Sponsored Research and have been signed by the Vice-President upon the recommendation of the appropriate Technical Director, the Director of the Office of Government Sponsored Research, and the Business Manager. I recommend your approval and ratification of signatures:

1. Contract AF 08(616)-55, by which the Department of the Air Force, Air Force Armament Center, Eglin Air Force Base, Florida, provides \$98,300.00 for a study of effects of variables on rocket trajectories. The contract is for the period March 1, 1956 through February 28, 1957, and the research is to be performed at the Military Physics Research Laboratory under the direction of Dr. M. Y. Colby, Professor of Physics.
2. Supplemental Agreement No. 9 to Contract AF 18(600)-647, by which the Department of the Air Force, Arnold Engineering Development Center, Tullahoma, Tennessee, adds the sum of \$6,854.48 to the contract funds and extends the contract period through June 15, 1956. The research on aerodynamics continues in the Defense Research Laboratory under the immediate supervision of Dr. M. J. Thompson, Professor of Aeronautical Engineering and Associate Director of the Laboratory.
3. Modification No. 3 to Contract DA 19-129-QM-150, by which the Department of the Army, Quartermaster Research and Development Center, Natick, Massachusetts, adds the sum of \$70,000.00 to the contract funds. The research on packaging materials and techniques in aerial delivery of supplies continues under the direction of J. Neils Thompson, Professor of Civil Engineering and Director, Structural Mechanics Research Laboratory.
4. Amendment No. 7 to Contract Nonr-375(01), by which the Department of the Navy, Office of Naval Research, adds the sum of \$50,000.00 to the contract funds, amends the scope of the work, and extends the contract period through April 30, 1957. The research on field and theoretical studies on propagation of millimeter radio waves continues under the direction of Dr. A. W. Straiton, Professor of Electrical Engineering and Director, Electrical Engineering Research Laboratory.
5. Amendment No. 6 to Contract Nonr-375(02), by which the Department of the Navy, Office of Naval Research, adds the sum of \$5,000.00 to the contract funds. The research on adsorption studies and corrosion reactions continues under the direction of Dr. Norman Hackerman, Professor of Chemistry and Director, Corrosion Research Laboratory.
6. Amendment No. 1 to Contract Nonr-1438(00), by which the Department of the Navy, Office of Naval Research, extends the contract period through February 28, 1958. The contract provides for continued use of Government-owned equipment for additional research on the effects of specific substances of growth. The research continues under the direction of Dr. W. G. Whaley, Professor of Botany and Director, Plant Research Institute.
7. Department of the Navy Sales Contract N-62779-58 which transfers title to the equipment and material held in the terminal inventory of Department of the Navy Contract N123s-67363, Task Order 2, to the University for the sum of \$244.00. Department of the Navy Contract N123s-67363, Task Order 2, covering research on high nitrogen compounds was conducted in the Chemistry Department under the direction of Professor George W. Watt.
8. Letter of extension dated March 14, 1956, by which the National Science Foundation extends Grant NSF-G61 to August 31, 1957, without an increase in the grant funds. The research on critical properties of some ethers and heterocyclic compounds continues under the direction of Dr. Kenneth A. Kobe, Professor of Chemical Engineering and Director, Bureau of Industrial Chemistry.

9. Grant W-69, by which the Department of Health, Education and Welfare, U. S. Public Health Service, provides \$25,428.00 for a comparative study of the development of general hospitals and services in two types of communities. The grant is for the period June 1, 1956 through May 31, 1957, and the research is to be directed by Dr. Ivan C. Belknap, Associate Professor of Sociology.

10. Grant C-2269(C2), by which the Department of Health, Education, and Welfare, U. S. Public Health Service, provides \$10,100.00 for research on genetic control of metabolism in Neurospora mutants. 2. Contract with Maufrais Brothers, Inc., for reconstruction of Waller Creek Bridge, signed on behalf of the University by Mr. G. W. Landrum, Business Manager. The amount of the contract is \$11,150 and completion date of the work about June 15, 1956.
3. Contract with John E. Miller, signed on behalf of the University by Mr. G. W. Landrum, Business Manager, providing for the construction of two chain link fences including gates (one between Blanton and Littlefield Dormitories, and one between Carothers and Littlefield Dormitories) and planting around them. The amount of the contract is \$10,221.06.
4. Contract with Otis Elevator Company, signed on behalf of the University by Mr. G. W. Landrum, Business Manager, in the amount of \$15,357, for modification of the Sutton Hall elevator.
5. Contract V4049V-695, with Veterans Administration, signed on behalf of the University by Vice-President C. P. Boner, for the training of veterans eligible under Public Laws 16 and 346, 78th Congress, as amended, covering the period September 14, 1955-August 31, 1956.
6. Supplements Nos. 1 and 2, to Contract V4049V-695 with Veterans Administration, signed on behalf of the University by Business Manager G. W. Landrum, which add the University of Texas Final Announcement of Courses, Spring Semester, 1955-56, Main University, and the University of Texas Publication No. 5605, Summer Session, 1956, Main University, to the terms of the original contract.
7. Agreement with Southwest Research Institute of San Antonio, signed on behalf of the University by Vice-President C. P. Boner, granting the Institute the right and privilege of using the Van de Graaff Electrostatic Generator, payment of rental for such use to be at a rate of Fifty Dollars per hour, and specifying 8 hours as a minimum and 14 hours as a maximum of time for which the machine is to be used under this agreement.

WILLIAM JAMES BATTLE MEMORIAL FUND: Friends of the late Professor W. J. Battle have established the William James Battle Memorial Fund, the purpose of which is to secure a permanent membership in the American Academy in Rome for the University as a memorial to Dr. Battle. The Department of Classical Languages requests, and I so recommend, that the University take over the custodianship of the accumulated funds and retain it until the necessary amount is secured.

PURCHASE FROM A STAFF MEMBER: I recommend approval of the request of the Department of Art to purchase out of its departmental Maintenance and Equipment fund from Mr. Loren Mozley, Associate Professor of Art, one hundred mounted 8" x 10" black and white photographs of Mexican architectural and archaeological subjects at a price of \$150.

SUMMER SESSION GEOLOGY FIELD COURSES: I recommend approval of the following changes in Field Expense fees for the Geology Field Courses for the 1956 Summer Session: Geology 660f, change from \$90.00 to \$105 per student. This fee covers student board and room costs. Geology 661f, change from \$15.00 to \$50.00 per student. This fee covers the full six weeks of lodging but only food for one-third of the time. All of these fees are estimates, and refunds will be made if any savings are made.

ROSALIE B. HITE FELLOWSHIPS: I concur in the following recommendations of the Rosalie B. Hite Fellowship Committee regarding the fellowship program:

Postdoctoral fellowships: \$3,600 for 12 months (one month vacation allowed) plus \$350 per year allowance for each dependent. (Maximum, \$4,650) (Present maximum, \$3,600, including six weeks' paid vacation)

Predocctoral fellowships: \$2,000 for 12 months (one month vacation allowed) plus \$350 per year allowance for each dependent (maximum \$2,700), plus tuition and fees. (Present maximum \$150 net a month plus required fees, and if granted for twelve months, a six weeks' paid vacation)

The Committee also unanimously recommends that, by special action of the Committee, candidates may be allowed the equivalent of one month's extra salary to cover travel expenses in order to make Hite Fellowships conform with other similar fellowships.

The Committee further requested a change in the relative emphasis on predocctoral and postdoctoral fellowships so that its hands would not be tied in choosing the best available candidates because of requirements as to academic level, location, or sex, and that the specific number of each type of fellowship be unstated.

GRADUATE FACULTY MEMBERSHIP: I concur in the recommendation of the Graduate Council that Mr. Philip D. Creer, Professor of Architecture, be made a Regular Member of the Graduate Faculty.

CLASSIFIED PAY PLAN: I recommend approval of the revised salary plan for classified personnel, effective September 1, 1956, copy of which is attached hereto as Appendix A. *See Page 788.*

APPOINTMENT TO ATHLETIC COUNCIL: Mr. J. Neils Thompson, Chairman of the Athletic Council, whose term expires August 31, 1956, has resigned, effective May 12, 1956. To fill his unexpired term and to fill the vacancy on the committee beginning September 1, 1956, I recommend Mr. M. L. Begeman, Professor of Mechanical Engineering. Dr. O. B. Williams will serve as Chairman succeeding Mr. Thompson.

4. Dr. E. F. Gloyna, Associate Professor of Civil Engineering, to act as consultant to Forrest and Cotton, Consulting Engineers,



CHANGES IN REQUIREMENTS FOR DOCTOR'S DEGREE: I recommend approval of the following legislation submitted by the Graduate Legislative Council to be inserted in the appropriate page of the Graduate Catalogue:

After a doctoral candidate has had his final copies of the doctoral dissertation approved by the supervising committee and after he has passed the final doctoral oral examination on the dissertation and on other aspects of his doctoral program, the applicant must arrange to pay \$20.00 to University Microfilms, Ann Arbor, Michigan, to cover the cost of the national publication of an abstract of the student's doctoral dissertation and to cover the cost of microfilm reproduction of his complete doctoral dissertation. For this purpose the student must deliver to the Office of the Dean of the Graduate School the signed original copy of his doctoral dissertation (unbound) which will be sent to University Microfilms for reproduction. The student must also deliver to the Office of the Dean of the Graduate School one carbon copy to be retained until the dissertation has been microfilmed and the original copy has been returned for permanent filing in the University Library. In a few divisions of the University an additional carbon copy is required for school or college libraries. The student is required to pay costs of binding.

Salary Ranges Covering
Classes of Positions in the Classified Service

EXPLANATION: Below are listed the salary ranges for classes of positions in the Classified Service of the University. The first column indicates the index number of the class; the second column, the class title; the third column, the monthly salary range for the class, i.e., the minimum and maximum rates to be paid to incumbents of positions of the class; the fourth column, the annual salary range for the class; the last column the salary step number, which refers to the Basic Salary Schedule (Table 2). The "intermediate steps" are those rates which fall between the indicated minimum and maximum rates and can be found in Table 2.

The salary ranges are intended to provide an equitable level of compensation for each class of employment. Ranges are determined through study and analysis of the following factors: Prevailing rates of pay for comparable employment by private and other public employers, present economic conditions, present labor market conditions, past University pay policies, and the relationship of the different classes of employment as determined through evaluation of duties and responsibilities of each position.
